The Town of Chapel Hill Board of Mayor & Alderman met for their regular monthly meeting on Monday, April 12, 2021 at 6:00 p.m. at Chapel Hill Town, 4650 Nashville Hwy, Chapel Hill, TN.

Members Present: Vice-Mayor Marion Joyce, Alderman Mike Faulkenberry, Alderman Horace Hill, Alderman Dottie Morton, Alderman Joe Sedlak, Alderman Brian Williams.

Also present were Town Administrator Mark Graves and Attorney Todd Moore.

Vice-Mayor Marion Joyce called the meeting to order at 1800.

Mark Graves called roll with Vice-Mayor Joyce, Alderman Faulkenberry, Alderman Hill, Alderman Morton, and Alderman Sedlak present. Alderman Williams arrived just after roll call at 1805.
